Constructed within the footprint of the hospital building, the new facility is a joint venture between MelroseWakefield Healthcare, Shields Health Care Group and Tufts Medical Center Physicians Organization. It will provide outpatient surgery by leading orthopedic; gastroenterology; and ear, nose and throat surgeons, including specialists from Tufts Medical Center, locally for patients. With three operating rooms and two procedural rooms, the ambulatory surgery center will provide high-quality services in a lower-cost setting for patients.

Even with all that was achieved this past year, still we are looking forward to doing more in the coming year. We are deeply committed to bringing the right level of care and services to our communities for the benefit and ease of our patients.

New Facility Will Provide High-Quality, Lower-Cost Outpatient Surgery Locally

Advancing local healthcare by providing more of the services that patients will need was a key focus of the work in 2019.

More than 14 months of collaborative community work culminated in the unanimous approval by Medford City Council for the development of a state-of-the-art ambulatory surgery center at the Lawrence Memorial Hospital campus in Medford.

The new 16,000 square-foot ambulatory surgery center is a joint venture between MelroseWakefield Healthcare, Shields Health Care Group and the Tufts Medical Center Physicians Organization. As care advances, an ambulatory surgery center offers a cost-effective and convenient environment for patients that many patients and surgeons prefer.

The one-story facility, built within the existing footprint of the hospital building, will provide outpatient surgery by leading orthopedic; gastroenterology; and ear, nose and throat surgeons, including specialists from Tufts Medical Center, locally for patients.

"It is an example of how we are working to advance community healthcare," said Sue Sandberg, MBA, RN, chief executive officer, MelroseWakefield Healthcare. "Massachusetts healthcare is among the most expensive, and our work to bring more services from academic Boston settings to community locations is fundamental to improving access and helping to lower cost."

The development of the ambulatory surgery center is also key to the overall transformation of the Lawrence Memorial Hospital campus that will have a greater

focus on the services that patients need. "The future of the Lawrence Memorial Hospital campus is one of comprehensive outpatient care for patients of all ages in one convenient, easy-to-get-to location," added Sandberg.

"Shields Health Care Group is thrilled to partner with MelroseWakefield Healthcare and the Tufts Medical Center Physicians Organization to bring this vision to life," said Tom Shields, president and CEO of Shields. "This new ASC will feature cutting-edge technology that is changing the way that healthcare is delivered. For patients, it means getting care that is high quality and low cost, in an attractive and convenient setting near home."

"I am excited about this project because it represents a further deepening of the affiliation between MelroseWakefield Healthcare and Tufts Medical Center," said Dr. Charles Cassidy, chair of the Department of Orthopedics at Tufts Medical Center and professor and chair of Orthopaedic Surgery for Tufts University School of Medicine. "This ambulatory surgery center is an opportunity for us to collectively provide outstanding care to our patients in a more convenient and lower-cost setting."

Construction of the ambulatory surgery center is expected to begin the beginning of the calendar year 2020 and take 12 to 14 months to complete.

Professional Dancer Overcomes Breast Cancer Thanks in Part to Early Detection

Meghan's first ever mammogram was at Lawrence Memorial Hospital of Medford and most likely saved her life.

Scheduled during the holiday season in December 2017, the 41-year-old mother and professional dancer almost postponed the appointment, but she decided to go ahead and check it off her list

Two mammograms and one biopsy later, Meghan was diagnosed with DCIS (ductal carcinoma in situ), stage zero breast cancer, the most common type of breast cancer.

"Everyone told me I was lucky, but I didn't feel like it," she recalls.

Meghan started treatment with Salvatore Nardello, DO, medical director at MelroseWakefield Breast Health Center in Stoneham. Dr. Nardello is one of two fellowship-trained breast surgeons and part of a team of professionals at the center who are dedicated to ensuring women receive the best possible medical treatment in a supportive environment locally.

"I treat people not cancer," said Dr. Nardello. "When treating Meghan, a lot of the aspects of her care were around her love of dance and being a mom."

Following lumpectomy procedures, Meghan's test results showed that the disease was still present.

Through a multidisciplinary partnership with Tufts Medical Center, Dr. Nardello met with Abhishek Chatterjee, MD, an

oncoplastic surgeon specialist and chief of plastic surgery, to review Meghan's case. Together they recommended a mastectomy to ensure that all the cancerous cells could be removed.

Meghan had a second opinion at a leading Boston cancer center to explore her options, but she said, "I came right back to Stoneham. I got the same treatment plan and recommendations [in Boston], but the care didn't feel as personal. That's huge because when you're going through this situation you really need support."

Meghan had a skin-sparing mastectomy at Tufts Medical Center with Dr. Nardello and Dr. Chatterjee. The combined procedure removes the tumor and begins the breast reconstruction process in the same surgery, which preserves more of the breast skin; avoids large, unsightly scars; and allows better reconstruction results.

"Although Meghan required a mastectomy, we are very progressive with breast conservation. A mastectomy with a big scar isn't what we do. All our patients right here in the community have access to this level of care," Dr. Nardello explained.

Just over a year after her reconstruction surgery, Meghan is living cancer free and has returned to her dance career. She plans to use it to help other women by launching a dance program for women with breast cancer.

"I'm doing great. I didn't feel lucky at the time, but I do now," she said.

Lifesaving Heart Pump at MelroseWakefield Hospital

Cardiologists and staff at MelroseWakefield Cardiovascular Center performed the first procedure using an Impella® pump.

The Impella pump is one of the newest advanced technologies in heart care, and it is available at MelroseWakefield Hospital – one of few community hospitals to provide this level of advanced technology and expertise for patients locally.

Impella is a tiny, temporary heart pump that is proven to be effective for treating high-risk heart failure. Once in place, it pumps blood for the left or right side of the heart during high-risk angioplasty procedures.

An example of the growing clinical services offered in collaboration with Tufts Medical Center, the first procedure was performed at MelroseWakefield Hospital by Laurence Conway, MD, medical director, Cardiology, and David Criss, MD, cardiologist from Tufts Medical Center.

In the last year, two patients have benefited from our team's use of this emergency, lifesaving device.
